**TO: ALL PERSONS WHO CLAIM DAMAGES AS A RESULT OF DR. NIKITA LEVY'S ALLEGED PHOTOGRAPHY, VIDEOTAPING OR BOUNDARY VIOLATIONS WHILE HE WAS EMPLOYED BY JOHNS HOPKINS FROM APRIL 26, 1988 UNTIL FEBRUARY 8, 2013**

**ON OCTOBER 30, 2013, A MANDATORY SETTLEMENT CLASS WAS CONDITIONALLY CERTIFIED IN THIS LAWSUIT AGAINST JOHNS HOPKINS CONCERNING THE ALLEGED MISCONDUCT OF THE DECEASED DR. NIKITA A. LEVY ("DR. LEVY").**

**1. Why are you receiving this notice?**

You are receiving this notice because records reflect that you may have been a patient or were treated by Dr. Levy while he was employed at Johns Hopkins between April 26, 1988 and February 8, 2013.

**2. What is this lawsuit about?**

Plaintiffs have filed a Class action lawsuit in the Circuit Court for Baltimore City, alleging they were injured and damaged by the deceased Dr. Nikita A. Levy and that The Johns Hopkins Hospital, Johns Hopkins Community Physicians, Inc. and The Johns Hopkins Health System Corporation is responsible for the damages sustained by members of the Class. The name of this lawsuit is *Jane Doe No. 1, et. al. v. Johns Hopkins Hospital, et. al.*, No. 24-C-13-10041.

The Plaintiffs allege that Dr. Levy secretly videotaped or photographed them, or that Dr. Levy engaged in physical boundary violations while treating them. While denying liability, Johns Hopkins has agreed to enter into settlement negotiations which may or may not settle the litigation on behalf of all Class members.

Establishment of this Class by the Court does not mean that any Class member will receive any money. In the event the settlement negotiations produce a settlement, the Court will provide further notice of the settlement's terms and any related proceedings. If the settlement negotiations do not produce a settlement, the Court will provide you a further notice regarding future proceedings and how to protect any rights you may have.

**3. What are my rights and obligations?**

- a. If you believe that you are a member of this Class by being a former patient of Dr. Levy or were secretly videotaped, photographed, or suffered boundary violations by Dr. Levy, you should complete the attached "Registration Form" and send it to:

- b. The attorneys on the Court-approved Steering Committee will act as your representatives during the settlement negotiations with Johns Hopkins.
- c. Your participation in any recovery will depend upon your participation in the Class and on the results of the settlement negotiations which may extend for a long period of time.
